Krantz & Carr: PHARMA- COLOGIC PRINCIPLES OF MEDICAL PRACTICE *New 4th edition*

The new edition of *Krantz & Carr* retains the authors' original purpose: to present the principles of the action of pharmacologic agents. Primarily a textbook, previous editions have found favor among practicing doctors because *Krantz & Carr* tells them *what* to do and *why*, *how* to do it and *when*.

Now enlarged, the text considers about 200 new drugs. Foremost among many new chapters is one on the treatment of mental illness. This classifies the tranquilizers (both chemically and pharmacologically), and clinically evaluates them. Psychologic and sociologic aspects of drug treatment of mental illness are discussed in the light of modern concepts. Also in this chapter is an evaluation of shock therapy and insulin coma.

Because over one-fifth of the patients who visit the g. p. present complaints relating to the eye, ear, nose and throat, *Krantz & Carr* now includes a chapter on the local use of drugs in these areas.

Other important changes include:

- Chapter on antibiotics completely revised
- Chapter added on drug treatment of allergy
- New chapter on treatment of hyperkinetic states
